



PACIFIC BALLROOM DANCE

Parent Contract

BILLING: The tuition fee, uniform fee, and other associated fees are due by/before the end of the registration period, which ends **September 18th**. All monthly payments will be due by the **1st** of every month. If you (parent) choose to pay your total annual tuition fee in full you will receive a **3% discount** off your tuition. If you elect to pay on a monthly payment plan, you will have a 15 - day grace period to pay your fees following the due date each month. A **\$10.00 late fee** will be assessed to your account for any payments received after the grace period.

CREDIT CARD REQUIREMENTS: We request a credit card number to be on file for each student. By signing this contract you agree to have your credit card charged for tuition plus any outstanding balance if payment is not received by the 15th of every month (for monthly payments). By signing below you understand that we will process your credit card for ANY balance due. If you do not have a credit card or refuse to provide us with your credit card you agree that if tuition is not received by the 20th of the month your child will not be permitted to attend classes until it is paid, or arrangements have been made with PBD staff. Tuition shall continue to accrue regardless of class attendance.

STUDIO USE: Students who pay the registration fee may sign up for studio time. They will be able to sign up for open floor time free of charge. Your student will be required to sign in and follow all rules. Pacific Ballroom Dance has the right to not allow a student to use the facility at any time. Pacific Ballroom Dance also has the right to remove the privilege for an extended period of time due to disciplinary problems that arise. You (parent) agree that you shall release and forever discharge Pacific Ballroom Dance and its employees from any expenses growing out of or related to any injury or damage that you (parent) or your child (student) may sustain as a result of his/her participation in or use of the Pacific Ballroom Dance studio, regardless of the specific cause thereof.

CLASS OBSERVATION: We request that parents remain in designated areas while class is in session.

DROPPING CLASS OR TEAM: If your child has made a performing team, you will not be reimbursed for any registration fee, competition fee, or other fees associated with team membership that you have paid in advance if your child drops out. By signing below you are agreeing to a nine month commitment to the team.

CLASS ATTENDANCE: If you attend a class that you are not registered for, you will be charged a drop-in rate for that class.

RELEASE: By signing this contract you (parent) agree to release and forever discharge Pacific Ballroom Dance and its employees from any expenses growing out of or related to any activities in which I (parent) or my child (student) may participate in. I (parent) understand that this is a full and complete release for all injuries or damages which I (parent) or my child (student) may sustain as a result of your/his/her participation in any activities, regardless of the specific cause thereof.

LIFTS/STUNTS: I (parent) am aware that my minor child (student) is dancing with Pacific Ballroom Dance. I have been made aware of the potential for injury involved in learning stunts, lifts, drops, and choreography in the dances that will be taught. I release Pacific Ballroom Dance, its instructors, and guest teachers of any responsibility should an injury occur while dancing in a practice, performance, or competition. I understand that all dancers participate at their own risk and are responsible for communicating to their instructors of an injury or inability to perform or compete a certain stunt, lift, drop or choreography of any kind.

PAYMENTS: We accept credit cards, check or cash payments. If a check is returned for "Non-Sufficient Funds", you will be charged a \$30.00 NSF fee. Any delinquent accounts after one month will be sent to collections unless payment arrangements have been made with PBD staff.

PARENT RESPONSIBILITY: PLEASE pick up your child after his/her class has ended. PLEASE do not leave your child here any longer than 15 minutes before or after their class schedule has started or finished. Parents may be charged a \$15.00 fee for students who are left unattended longer than 15 minutes to help pay for the instructors' time. THANK YOU!

CLASS ATTENDANCE: No credit or refund will be given for classes that your child is unable to attend. The student must inform the instructor if he/she is going to miss a class so the instructor can make arrangements, if necessary, for his/her partner.

DANCE TEAM MEMBERS AND PARENTS: By signing this contract you (parent) agree that you (parent) will be responsible for your child's registration fees, fundraising fees, and other applicable fees during the season. You (parent) understand that there will be a late fee assessed for late payments and a fee assessed for leaving your child later than 15 minutes after class time. You (parent) agree that Pacific Ballroom Dance holds you (parent) accountable for the money due and that the Pacific Ballroom Dance representative will not discuss financial concerns/issues with the student but directly with you (parent). You (parent) understand that without this signed contract and signed registration form, your child cannot participate in Pacific Ballroom Dance Activities.

ENFORCEMENT: If any legal action arises from the provisions of this agreement, the prevailing party is entitled to recover its attorney's fees and costs.

DENIAL TO RELEASE NAMES/PHOTOGRAPHS

Pacific Ballroom Dance may release name of student, photographs, awards received, and other student accomplishments, if signature is received by the parent/guarding of said student.
